We were also celebrating the recent Tech Hubs announcement by the U.S. Economic Development Administration (EDA). Last week the EDA announced \$504 million in implementation grants to 12 previously designated Tech Hubs, including the Elevate Quantum Tech Hub right here in Colorado! This announcement underscores our region and state's commitment to innovation and technological advancement, while highlighting the ongoing potential for economic growth and leadership in quantum information technology (QIT) and other advanced industries.

The Elevate Quantum Tech Hub, led by Elevate Quantum, is a consortium of approximately 120 organizations working together to position the region as the global epicenter for QIT development, enhancing U.S. economic and national security. The grant funding recommended for the Elevate Quantum Tech Hub will support constructing open-access quantum labs and fabs to enable rapid prototyping and manufacturing of critical quantum technologies. It will also support workforce development programs and ongoing stakeholder and investor engagement.

While the Longmont EDP is not an official member of the Elevate Quantum consortium, we offer our heartfelt congratulations and are excited at the possibilities ahead. The ripple effects of this designation will extend throughout Boulder County, the Front Range, the State, and ultimately the world. Elevate Quantum is collaborating with industry partners, education and research institutions, workforce partners, and others to spur the development of new technologies, bolster our economy, and solidify Colorado's reputation as a powerhouse of technological advancement. We look forward to supporting this work and look forward to all the possibilities ahead!

Applications Open for the Advanced Industries Accelerator Grant Programs

The Office of Economic Development and International Trade (OEDIT) is accepting Advanced Industries Accelerator Program applications for the first grant cycle of fiscal year 2025. Online applications are being accepted for the <u>Proof of Concept Grant</u> and <u>Early Stage Capital and Retention Grant</u>. Applications are due by 5:00 pm MST on August 29, 2024.

The Advanced Industries Accelerator Programs were created in 2013 to promote growth and sustainability in Colorado's advanced industries by helping drive innovation, accelerating commercialization, encouraging public-private partnerships, increasing access to early stage capital and supporting Colorado's advanced industries, which include:

- · Advanced manufacturing
- Aerospace
- Bioscience
- Electronics
- Energy and natural resources
- Infrastructure engineering
- Technology and information

<u>Early-Stage Capital and Retention grants</u> fund companies commercializing innovative technologies to create viable products that meet a market need and can be created or manufactured in Colorado and exported globally. Grants up to \$250,000 will be awarded.

Apply online through August 29, 2024

Proof of concept grants are only open to approved Colorado research universities and federal labs located in Colorado.

City Updates

Construction Begins on Coffman St.

Construction on the \$17 million Coffman Street transportation project started the week of July 1st. This initiative aims to create a safer and more reliable corridor for all modes of travel, including buses, cars, bicycles, and pedestrians. Key features include Bus Rapid Transit (BRT) lanes and

new separated bicycle lanes, which will connect to the future First and Main Transit Station. The project will be completed in two phases:

- Phase One: Focuses on the west side of Coffman Street, transforming the area between Ninth and Sixth avenues with one-way northbound traffic and removal of on-street parking. This phase is expected to be completed by spring 2024.
- Phase Two: Shifts to the east side of Coffman Street, from Ninth Avenue to Sixth Avenue, introducing one-way southbound traffic. This phase will overlap slightly with the first phase.

The project is supported by \$7.75 million from state and federal sources, with the City of Longmont covering the remaining \$9.25 million. Construction will take place from 7 a.m. to 6 p.m., Monday through Friday, with some work on Saturdays. The entire project is expected to be completed by summer 2026, significantly enhancing Longmont's transportation infrastructure and providing safer, more efficient travel options for the community.

Transportation Mobility Plan

The City of Longmont will be releasing a community survey and presenting draft recommendations for their Transportation Mobility Plan at a public meeting on July 18, 5:30 pm at the Longmont Public Library. The City is looking for feedback on the plan, which aims to improve walking and biking access and enhance transit connections, aligning with Longmont's safety and sustainability goals. The final plan will guide Longmont's near-term and future public investment in transportation safety and infrastructure improvements.
